Agenda Item No. 20.2: Update on NIRF Ranking.

The Director, IQAC, informed all members that the University had applied for the NIRF Rankings in January 2025 under three categories: Overall, Medical, and SDG. The University made its debut in the NIRF ranking bands in the following categories:

- **University:** Ranked in the 101–150 band
- **Overall:** Ranked in the 151–200 band
- **Medical:** Very close to Top 50 Institutions as per results announced by NIRF.

SRHU's performance in the NIRF Rankings within Uttarakhand is as follows:

- **Top 3** institutions in the **Medical** category
- **Top 4** institutions in the **University** category
- **Top 6** institutions in the **Overall** category

The NIRF result gap analysis has been presented, along with the identified areas of improvement, which are summarized below:

The Vice Chancellor inquired about the placement status of the skill-oriented, three-year Bachelor of Vocation (B.Voc.) program currently offered by the University. Dr. Mukesh Bijalwan informed the members that the program is being conducted in accordance with the provisions of the National Education Policy (NEP). *After considering the members' opinions,*

it was decided to include this program in AISHE, NIRF, NAAC, and other relevant submissions starting from the academic year 2024–25 onward.

Agenda Item No. 20.3: Update on “QS I-Gauge Rating” work and QS-Asia Requirements.

Update on **QS I-Gauge Rating work and QS-Asia Requirements** were discussed and are highlighted below:

QS-I-Gauge - The Director IQAC, apprised the house that 90% of the work has been completed, and the remaining documents are expected to be submitted in the near future. The Director General (Academic Development) further noted that most of the tasks have been completed by the team, except for the Seed Money Proposals and Employability sections. He requested all Deans and Principals of Academic Units to extend their full support to the Director (Research) for the immediate completion of the pending work.

The Director IQAC, emphasized the need to complete the QS-I-GAUGE work on priority, considering the upcoming commitments related to the NAAC-AQAR 2024-25 submission and the NIRF 2026 application, both scheduled for completion by the end of December 2025.

QS Asia - Director IQAC mentioned that University has decided to participate in QS Asia Ranking in 2027, therefore it is the high time to take following initiatives:

- i. To create the **Office of International Affairs** alongwith designating someone as Director.
- ii. International students' admission from 2025-26 Academic
 - a) Identify the Programmes Names
 - b) Finalize the Fee Structure of identified Programmes
- iii. International Hostel

The Vice Chancellor mentioned that the work is under progress and will be implemented in the near future.

Agenda Item No. 20.4: Report on University Level Internal and External “Academic Audit” and “Administrative Audit” for AY 2024-25.

The Director IQAC briefly mentioned about the Audit Process followed by the University and presented the University Level Academic Audit Report and Administrative Audit Report for the academic year 2024-25. The performance of all academic units and administrative units were presented alongwith the Suggestions / Recommendation of both Internal and External Audit Committees, which includes:

1. Functional ERP
2. Explore Possibilities of NBA Accreditation of Engineering and Management Programmes, for better placements opportunities.
3. R&D Cell Data needs wider dissemination for both inhouse and outside stakeholders.
4. Improve upon Quality Placements
5. Need to Strengthen Alumni Connect /Network

6. Focus on Outreach and Inclusion Activities for enhancing the Perception of the University.
7. Faculty Development Programmes to be organized by the Academic Units in the emerging areas in collaboration with IQAC of the University.
8. Roles and Responsibilities of officials and staff of all administrative units should be well defined and described.
9. SOPs and Procedures for all Academic and Administrative units to improve their functioning.

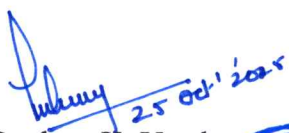
Agenda Item No. 20.5: Website Update in view of Accreditation, Rankings and Ratings


The Director IQAC emphasized that all Academic and Administrative Units, including Deans and Directors, should update the University website on a monthly basis to support accreditation, ratings, and ranking processes. The Vice Chancellor directed the General Manager – IT to review the existing processes and SOPs and to initiate this work as a matter of utmost priority.

- ii) Prof. P.D. Juyal advised all Deans and Principals of the constituent academic units to conduct **quarterly reviews of the seed money projects funded by the University**, in order to enhance outcomes in the form of quality research publications and patents. He emphasized that such efforts would contribute significantly to improve the University's rankings and ratings across various platforms.

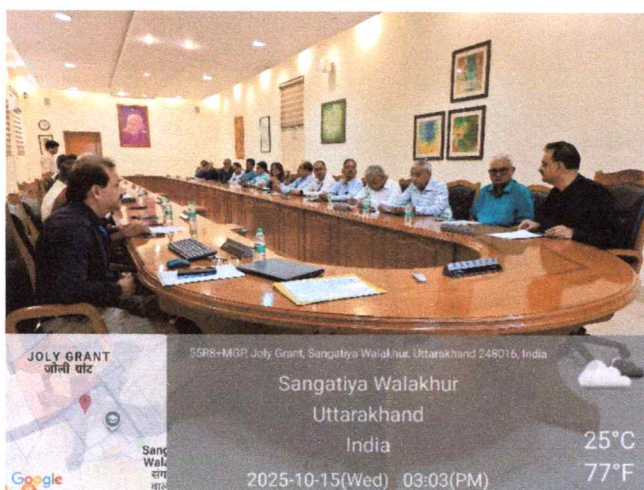
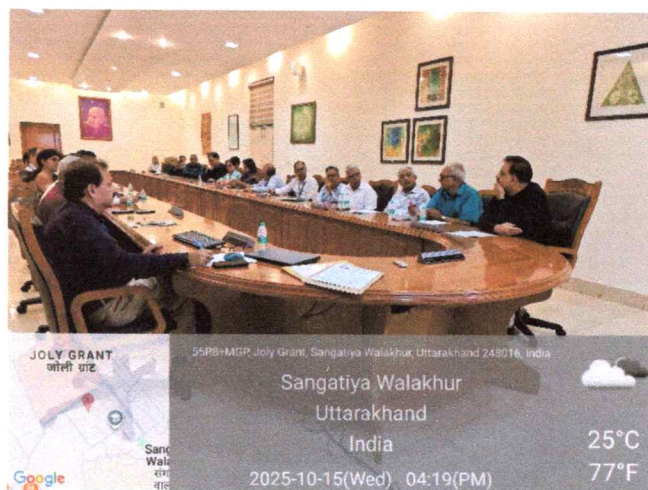
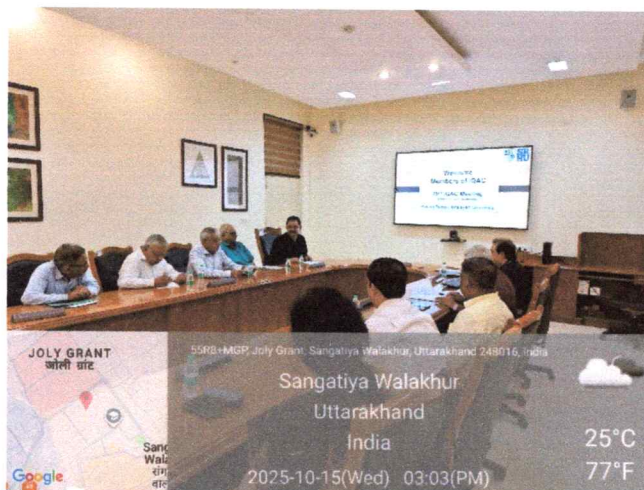
